Fifth meeting of the Assembly Abu Dhabi, 17 – 18 January 2015

Report of the Director-General on the Indicative IRENA Scale of Contributions for 2015

- 1. The Assembly in its Decision A/4/DC/1 adopted the Work Programme and Budget for the 2014-2015 biennium comprising core budget appropriations of USD 40 million across the biennium.
- 2. In accordance with Financial Regulation 6.1, the IRENA Scale of Contributions is based on the United Nations Scale of Assessments which has been adjusted to take into account the difference in membership between the Agency and the United Nations. The Indicative IRENA Scale of Contributions for 2014, contained in Annex II of the Work Programme and Budget for 2014-2015 (A/4/3), is based on 124 Members and totals 20 million for the first year of the biennium.
- 3. Since the adoption of the Work Programme and Budget for 2014-2015 on 18 January 2014, a number of countries have joined the Agency. The Indicative IRENA Scale of Contributions contained in the Work Programme and budget for 2014-2015 thus needs to be adjusted to account for additional Members.
- 4. At the eighth meeting of the Council, Members considered the Indicative IRENA Scale of Contributions for 2015 as contained in document C/8/13 and decided to submit it to the Assembly for its consideration, noting that further adjustments may be necessary for new Members joining the Agency until the fifth session of the Assembly.
- 5. The Indicative IRENA Scale of Contributions for 2015, totaling USD 20 million, is based on 139 Members. This Scale is contained in the Annex of the present document and is being presented to the Assembly for its consideration.
