Report

A. Opening of the session

- 1. At the invitation of the Federal Government of Germany, together with the Governments of the Kingdoms of Denmark and Spain, the Conference on the Establishment of the International Renewable Energy Agency (IRENA) convened at the World Conference Center in Bonn on 26 January 2009.
- 2. Representatives of 124 States, as contained in Annex 1, and one regional intergovernmental economic integration organisation, the European Community, participated in the Conference.
- 3. 7 international organisations and 40 other organisations and guests whose work is related to that of the International Renewable Energy Agency, participated in the Conference as observers (Annex 2).
- 4. The Conference was chaired by the host government.
- 5. The Conference was formally opened by H.E. Mr. Sigmar Gabriel, Federal Minister for the Environment, Nature Conservation and Nuclear Safety of Germany.

B. Statement of the host Government

6. On behalf of the Federal Government of Germany, Gernot Erler, Minister of State at the Federal Foreign Office, welcomed the participants to the Conference.

C. Organisational matters

I. Election of Vice-Chairs

7. On the proposal of the Chair, the Conference elected H.E. Ms. Connie Hedegaard, Minister for Climate and Energy of Denmark, and H.E. Don Miguel Sebastián, Minister of Industry, Tourism and Trade of Spain, as Vice-Chairs.

II. Adoption of the agenda and the rules of procedure

- 8. The Conference adopted its agenda as contained in Annex 3.
- 9. The Conference adopted its rules of procedure as contained in Annex 4.

III. Election of officers

- 10. At the proposal of the Chair, the Conference appointed Mr. Malek Kabariti, President of the National Energy Research Center of Jordan, as Rapporteur.
- 11. The Depositary designated Mr. Thomas Meister, Head of Division, International Energy Policy in the Federal Foreign Office of Germany, as Secretary-General of the Conference.
- 12. The Conference established a Credentials and Full Powers Committee, consisting of representatives from Austria, Benin, Chile, Finland and the Republic of Korea.

D. Editorial changes of the Statute

- 13. The Chair noted that the depositary introduced a few purely editorial changes in Article X paragraph A, Article XI paragraph F, Article XV paragraph B, and Article XX paragraphs E and F of the Statute as contained in Annex 5. No objections were received on this issue within the time frame given by the Chair.
- 14. One delegation asked the Secretariat to restructure the Articles of the Statute, but agreed that this proposal came too late. Since this would have had no effect on the substance of the Statute, the delegation did not insist on its proposal and asked instead to attach this proposal to the conference report (Annex 6).

E. Declaration of the Conference on further authentic versions of the Statute

15. The Federal Government of Germany proposed and circulated a declaration allowing for the authentication of the Statute in the official UN languages other than English and the language of the Depositary upon the request of the respective Signatory. The full text of the declaration is contained in Annex 7.

The Chair noted the understanding of the meeting that this declaration shall not be in conflict with the agreement of States having attended the Berlin Workshops and the Final Preparatory Conference in Madrid with respect to the working language. This means that there shall be one working language, which shall be English. Other languages can become working languages only if the Assembly so decides.

Before the signing ceremony of the Statute, the Conference adopted this declaration.

F. Statements

- 16. H.E. Mr. Andris Piebalgs, Energy Commissioner of the European Commission, and H.E. Ms. Amina Benkhadra, Minister for Energy, Water, Mines and the Environment of Morocco, addressed the Conference.
- 17. H.E. Mr. Sigmar Gabriel, Federal Minister for the Environment, Nature Conservation and Nuclear Safety of Germany, also addressed the Conference.
- 18. In the course of the Conference, the representatives of the following 60 participating States made statements regarding IRENA:

Afghanistan, Albania, Algeria, Argentina, Austria, Bahrain, Belarus, Benin, Central African Republic, Chile, Czech Republic, Democratic Republic of the Congo, Denmark, Djibouti, Ecuador, Egypt, Eritrea, Ethiopia, Finland, France, Gambia, Ghana, Greece, Iceland, Iran (Islamic Republic of), Italy, Japan, Jordan, Lithuania, Madagascar, Malaysia, Mali, Mongolia, Montenegro, Nepal, Netherlands, Nicaragua, Niger, Nigeria, Norway, Oman, Peru, Philippines, Poland, Portugal, Republic of Korea, Romania, Senegal, South Africa, Spain, Sweden, Syrian Arab Republic, Tajikistan, The former Yugoslav Republic of Macedonia, Tunisia, Turkey, Uganda, United Arab Emirates, Uruguay and Zambia.

In its statement, the Austrian Delegation announced its wish to apply for the seat of the Agency's Secretariat to be situated in Vienna, Austria. The Austrian Delegation also announced that it is prepared to host a retreat-type seminar for all the Signatories of IRENA this spring in Vienna.

The Delegation of Egypt announced that it offers to host the second session of the Preparatory Commission in June 2009.

In its statement, the Delegation of the United Arab Emirates expressed its willingness to have Abu Dhabi serve as the seat of the Agency's Secretariat.

G. Credentials and full powers report

19. The spokesperson of the Credentials and Full Powers Committee presented the provisional report of the Committee. According to this report, 75 States are eligible and have shown their willingness to sign the Statute. The final report is contained in Annex 8.

H. Signing of the Statute of IRENA

20. H.E. Ms. Heidemarie Wieczorek-Zeul, Federal Minister for Economic Cooperation and Development of Germany, as Chair and H.E. Don Miguel Sebastián as Vice-Chair addressed the Conference, opening the afternoon meeting.

- 21. The Chair opened the Statute of the International Renewable Energy Agency for signatures. The text of the Statute is contained in Annex 9.
- 22. 75 States participating in the Conference signed the Statute during the signing ceremony (Annex 10).

I. Adoption of the resolution on establishing a Preparatory Commission

23. The Conference adopted the resolution on establishing a Preparatory Commission for the International Renewable Energy Agency (IRENA) as contained in Annex 11.

J. Adoption of the conference report and closure of session

- 24. The Conference adopted this conference report.
- 25. H.E. Ms. Heidemarie Wieczorek-Zeul addressed the Conference and declared the Conference closed.

Decision FC/dc.1 on Adopting the Rules of Procedure of the Conference on the Establishment of the International Renewable Energy Agency

The Conference on Establishing the International Renewable Energy Agency,

adopts the following rules of procedure for this Conference:

I. REPRESENTATION AND CREDENTIALS

Rule 1: Participants of the Conference

States and regional intergovernmental economic integration organisations invited to participate in the Conference shall be entitled to take part in the Conference and its decision-making.

Rule 2: Delegations and representatives

- 1. The delegation of a participant shall consist of a head of delegation and such other alternates and advisers as may be required.
- 2. The head of the delegation of a participant serves as its representative. The head of delegation may designate an alternate or adviser to act as a representative in his or her

place. The term "representative" in these rules refers to representatives of participants according to rule 1.

Rule 3: Credentials and full powers

- 1. Full powers are required for signing the Statute of the International Renewable Energy Agency and for adopting the resolution on the establishment of a Preparatory Commission. Such powers may be included in the credentials.
- 2. Credentials and full powers shall be issued by the Head of State or Government or by the Minister for Foreign Affairs or in case of a regional intergovernmental economic integration organisation by the competent authority.
- 3. The credentials of representatives as well as the names of alternate representatives and advisers and the full powers shall be deposited at the opening of the Conference with the Credentials and Full Power Committee of the Conference. Copies thereof, including a translation into English, should be submitted to the Government of Germany not later than 16 January 2009.

Rule 4: Credentials and Full Powers Committee

The Conference shall establish a Credentials and Full Powers Committee, which shall consist of five representatives appointed by the Conference on proposal of the Chair. The Committee shall examine the credentials and full powers of representatives and report to the Conference without delay.

Rule 5: Provisional participation

Until the decision of the Conference upon their credentials and full powers, representatives shall be entitled to participate provisionally in the Conference.

II. SECRETARIAT

Rule 6: Duties of the Secretariat

1. The Conference shall have a Secretariat provided by the Depositary. The Secretariat shall make all arrangements relating to meetings and provide for the reception,

translation, reproduction and distribution of the required documents, for the interpretation

of oral interventions and for the performance of all other secretarial work required for the

Conference.

2. The Secretary-General of the Conference, designated by the Depositary, shall assist

the Chair and Vice-Chairs. He or she shall act in that capacity in all meetings. He or she

may designate another member of the secretariat to replace him or her in case of

absence.

III. CHAIR and OFFICERS

Rule 7: Chair and Vice-Chairs

1. The Conference will be chaired by the host government.

2. The Conference shall elect two Vice-Chairs on proposal of the Chair. The Conference

shall also elect such other officers as it deems necessary for the performance of its

functions.

Rule 8: General powers of the Chair

1. The Chair shall preside at the meetings of the Conference, declare the opening and

closing of each meeting, direct the discussion, ensure observance of these rules, accord

the right to speak, promote the achievement of general agreement, put questions to the

Conference for decision, announce the necessary majority in accordance with these rules

of procedure and announce the result of decisions. Subject to these rules, the Chair shall

have control of the proceedings and over the maintenance of order thereat and take the

necessary decisions therefore.

2. The Chair, in the exercise of his or her functions, remains under the authority of the

Conference.

Rule 9: Acting Chair

The Chair may designate one of the Vice -Chairs to take his or her place. A Vice-Chair acting as Chair shall have the same powers and duties as the Chair.

Rule 10: Participation of the Chair in decision-making

The Chair, or a Vice-Chair acting as Chair, shall not participate in decisions to be made by the Conference, but shall appoint another member of his or her delegation to act as a representative in his or her place.

IV. CONDUCT OF BUSINESS

Rule 11: Points of order

During the discussion of any matter, a representative may at any time raise a point of order, which shall be decided immediately by the Chair in accordance with these rules. A representative may appeal against the ruling of the Chair. The appeal shall be put to the Conference for decision immediately and the Chair's ruling shall stand unless overruled by a majority of the representatives present and voting. A representative may not, in raising a point of order, speak on the substance of the matter under discussion.

Rule 12: Speeches and interventions

- 1. Representatives may ask for the floor in order to address the Conference.
- 2. Representatives may not address the Conference without having previously obtained the permission of the Chair.
- 3. The Chair shall subject to rules 11 and 15 to 17 call upon speakers in the order in which they signify their desire to speak.
- 4. The Chair may also ask the speaker not to depart from the subject.

Rule 13: List of speakers and time to speak

During the course of a debate the Chair may announce the list of speakers. With the consent of the Conference he may declare the list of speakers closed, limit the time to be allowed to speak and the number of times each representative may speak.

Rule 14: Rights of reply

Notwithstanding rule 13 the Chair shall accord the right of reply to a representative who requests it.

Rule 15: Suspension or adjournment of the meeting

A representative may at any time move the suspension or the adjournment of the meeting. Such motions shall not be debated but shall be put by the Chair immediately to the Conference for decision.

Rule 16: Adjournment of debate

A representative may at any time move the adjournment of the debate on the question under discussion. In addition to the proposer of the motion, two representatives may speak in favor of, and two against the adjournment, after which the motion shall be put by the Chair immediately to the Conference for decision.

Rule 17: Closure of debate

A representative may at any time move the closure of the debate on the question under discussion, whether or not any other representative has signified a wish to speak. Permission to speak on the closure of the debate shall be accorded only to two speakers opposing the closure, after which the motion shall be put by the Chair immediately to the Conference for decision.

Rule 18: Order of motions

The motions indicated below shall have the precedence in the following order over all other proposals or motions before the meeting:

- a.) to suspend the meeting;
- b.) to adjourn the meeting;
- c.) to adjourn the debate on the question under discussion;
- d.) to close the debate on the question under discussion.

V. DECISION-MAKING

Rule 19: Rights to vote

Only participants according to rule 1 shall have the right to vote. Each participant shall have one vote.

Rule 20 Consensus and majority

The Conference shall take decisions on questions of procedure by a simple majority of the representatives present and voting. Decisions on matters of substance shall be taken by consensus of the representatives present or, if no consensus can be reached, by a vote of two-thirds majority of the representatives present and voting. When the issue arises as to whether the question is one of substance or not, that question shall be treated as a matter of substance unless the Conference by consensus of the representatives present or, if no consensus can be reached, by a vote of two-thirds majority of the representatives present and voting decides otherwise.

Rule 21: Method of voting

The Conference shall normally vote by show of hands, but any representative may

request a roll-call. The roll-call shall be taken in the English alphabetical order of the

names of the state and regional economic integration organisations, beginning with the

delegation whose name is drawn by lot by the President. Each name shall be called in all

roll-calls and its representative shall reply "yes", "no" or "abstention".

Rule 22: Signature of the Statute of the International Renewable Energy Agency

After the closure of debate, the Statute of the Renewable Energy Agency will be

submitted to the representatives for signature in the English alphabetical order.

Rule 23: Resolution on the establishment of a Preparatory Commission for the International

Renewable Energy Agency

After the signature of the Statute of the International Renewable Energy Agency, the

Conference should adopt a resolution on the establishment of a Preparatory Commission

for the International Renewable Energy Agency by consensus of the Signatories present

or, if no consensus can be reached, by a vote of two-thirds majority of the Signatories

present and voting.

VI. LANGUAGES AND RECORDS

Rule 24: Language of the Conference

English shall be the official language of the Conference.

Rule 25: Interpretation

- 1. A representative may make an intervention in any of the official languages of the United Nations and the language of the host government.
- 2. Interventions made in any of the official languages of the United Nations or the language of the host government shall be interpreted into the other official languages of the United Nations and the language of the host government.

Rule 26: Language of official documents

Official documents of the Conference shall be made available in the official language of the Conference.

Rule 27: Rapporteur, report and records

- 1. The Conference shall appoint a Rapporteur on proposal of the Chair.
- 2. The report of the Conference shall record the course of the meeting and very briefly summarize speeches. It shall mention interventions, proposals, the outcome of debates, the procedure of voting and the adoption of decisions of the Conference as well as the report of the Credentials and Full Powers Committee.
- 3. Each representative shall be entitled to ask for any statement made by him or her to be included in the reports either verbatim or in summary form, provided the English text is handed to the Secretariat in writing before the adoption of the report at the end of the Conference.
- 4. At the end of the Conference the Rapporteur shall submit the report to the Conference for adoption. If the Conference decides that amendments to the report are necessary the report shall be amended and submitted to the Conference again immediately.
- 5. After being adopted by the Conference the report shall be signed by the Chair, the Vice-Chairs, the Secretary General and the Rapporteur.

6. The report shall be deposited in the archives of the Depositary. Copies of the report

shall be distributed to the participants of the Conference.

4. Summary records of the Conference shall be kept and published by the Depositary in

the official language of the Conference.

VII. OBSERVERS

Rule 28: Attendance of observers

1. Any entity and any international organisation or any other organisation whose work is

related to that of the International Renewable Energy Agency having received an

invitation to attend the Conference as an observer, may attend the Conference as an

observer unless otherwise decided by the Conference.

2. The Conference may decide to allocate documents to observers.

VIII. AMENDMENT OF THE RULES OF PROCEDURE

Rule 29: Method of amendment

These Rules of Procedure may be amended by a decision by consensus of

Statute of IRENA- Purely Editorial Changes

Entrusted by States at the Final Preparatory Conference in Madrid with the responsibilities of the Depositary of this Statute, the Federal Government of Germany regards it as its duty to inform Signing States before signing the Statute that we have made some purely editorial changes in order to correct some grammatical and linguistic errors.

- 1. In Article X paragraph A we introduced "number of" in front of "Members" since this reflects the intended meaning more precisely.
- 2. In Article X paragraph A we replaced "voting period" by "election" since Council members need not necessarily to be elected by a vote but can be elected by consensus as well. "Election" is the precise meaning of the sentence, which can also be seen in the next line where the text refers to "members ... shall be elected".
- 3. In Article XI paragraph F we introduced "shall" in front of "not seek to influence" for linguistic reasons.
- 4. In Article XV paragraph B we moved "when" to number 1 since "when" only refers to number 1 and does not fit with number 2.
- 5. In Article XX paragraph E we introduced "any instrument of" after "deposit of". As can be seen in paragraph A, States have to deposit instruments of ratification.
- 6. In Article XX paragraph F we deleted "other" in front of "Members" since "other" may lead to confusion. According to the meaning of paragraph F, all Members and Signatories shall be informed by the Depositary, not only other Members.

We would like to ask delegations to inform the Conference Secretariat by 12.00 p.m. at the latest if they had any objections to these clarifications.

Article X

The Council

A. The Council shall consist of at least 11 but not more than 21 representatives of the Members of the Agency, elected by the Assembly. The concrete number of representatives between 11 and 21 shall correspond to the rounded up equivalent of one third of the Members of the Agency to be calculated on the basis of the number of Members of the Agency at the beginning of the respective voting period election for members of the Council. The members of the Council shall be elected on a rotating basis as laid down in the rules of procedure of the Assembly, with a view to ensuring effective participation of developing and developed countries and achieving fair and equitable geographical distribution and effectiveness of the Council's work. The members of the Council shall be elected for a term of two years.

- B. The Council shall convene semi-annually and its meetings shall take place at the seat of the Agency, unless the Council decides otherwise.
- C. The Council shall, at the beginning of each meeting for the duration until its next meeting, elect a Chairperson and such other officials from among its members as may be required. It shall have the right to elaborate its rules of procedure. Such rules of procedure have to be submitted to the Assembly for approval.
- D. Each member of the Council shall have one vote. The Council shall take decisions on questions of procedure by a simple majority of its members. Decisions on matters of substance shall be taken by a majority of two thirds of its members. When the issue arises as to whether the question is one of substance or not, that question shall be treated as a matter of substance unless the Council, by a majority of two thirds of its members, decides otherwise.

[Article XI]

F. In the performance of their duties, the Director-General and the other members of the staff shall not seek or receive instructions from any government or from any other source external to the Agency. They shall refrain from any action that might reflect on their positions as international officers responsible only to the Assembly and the Council. Each Member shall respect the exclusively international character of the responsibilities of the Director-General and the other members of the staff and shall not seek to influence them in the discharge of their responsibilities.

Article XII

The budget

- A. The budget of the Agency shall be financed by:
 - 1. mandatory contributions of its Members, which are based on the scale of assessments of the United Nations, as determined by the Assembly;
 - 2. voluntary contributions; and
 - 3. other possible sources

Article XIV

Relations with other organisations

Subject to the approval of the Assembly the Council shall be authorised to conclude agreements on behalf of the Agency establishing appropriate relations with the United Nations and any other organisations whose work is related to that of the Agency. The provisions of this Statute shall not affect the rights and obligations of any Member deriving from any existing international treaty.

Article XV

Amendments and withdrawal, review

- A. Amendments to this Statute may be proposed by any Member. Certified copies of the text of any amendment proposed shall be prepared by the Director-General and communicated by him to all Members at least ninety days in advance of its consideration by the Assembly.
- B. Amendments shall come into force for all Members when:
 - 1. <u>when</u> approved by the Assembly after consideration of observations submitted by the Council on each proposed amendment; and
- 2. after all the Members have consented to be bound by the amendment in accordance with their respective constitutional processes. Members shall express their consent to be

Article XX

Depositary, registration, authentic text

- A. The Government of the Federal Republic of Germany is hereby designated as the Depositary of this Statute and any instrument of ratification or accession.
- B. This Statute shall be registered by the Depositary Government pursuant to Article 102 of the Charter of the United Nations.
- C. This Statute, done in English, shall be deposited in the archives of the Depositary Government.
- D. Duly certified copies of this Statute shall be transmitted by the Depositary Government to the governments of States and to the executive organs of regional intergovernmental economic integration organisations which have signed or have been approved for membership according to Article VI paragraph B number 2.
- E. The Depositary Government shall promptly inform all Signatories to this Statute of the date of each deposit of <u>any instrument of</u> ratification and the date of entry into force of the Statute.
- F. The Depositary Government shall promptly inform all Signatories and other Members of the dates on which States or regional intergovernmental economic integration organisations subsequently become Members thereto.

I. Introduction

- 1. In accordance with rule 4 of its rules of procedure, the Conference established the Credentials and Full Powers Committee consisting of the following five States as members: Austria, Benin, Chile, Finland and the Republic of Korea.
- 2. The Committee met from 14:00 to 16:45 on 26 January 2009.
- 3. The Credentials and Full Powers Committee elected Mr. Krepela from Austria as the spokesperson.
- 4. At its meeting, the Committee noted rule 3 of the rules of procedure of the Conference, which provides:
 - "1. Full powers are required for signing the Statute of the International Renewable Energy Agency and for adopting the resolution on the establishment of a Preparatory Commission. Such powers may be included in the credentials.

 - 3. The credentials of representatives as well as the names of alternate representatives and advisers and the full powers shall be deposited at the opening of the Conference with the Credentials and Full Power Committee of the Conference. Copies thereof, including a translation into English, should be submitted to the Government of Germany not later than 16 January 2009."

II. Examination of credentials and full powers

- 5. The Committee reviewed the credentials and full powers submitted in accordance with rule 3 number 3 of the rules of procedure of the Conference and a memorandum of the Federal Government of Germany, dated 26 January 2009, concerning the credentials, full powers and corresponding documents of the representatives to the Conference. The Committee determined the following:
 - a) The following 50 participating States submitted the credentials and full powers in full compliance with rule 3 of the rules of procedure of the Conference: Algeria, Armenia, Austria, Bahrain, Benin, Cape Verde, Central African Republic, Chad, Chile, Comoros, Cyprus, Democratic Republic of the Congo, Denmark, Djibouti, Egypt, Eritrea, Finland, Gambia, Germany, Greece, Guinea-Bissau, Iceland, Iran (Islamic Republic of), Ireland, Italy, Jordan, Liberia, Lithuania, Mali, Mongolia, Morocco, Nepal, Niger, Norway, Portugal, Republic of Moldova, Romania, Sao Tome and Principe, Senegal, Serbia, Spain, Sweden, Syrian Arab Republic, The former Yugoslav Republic of Macedonia, Tunisia, Turkey, Uganda, United Arab Emirates, Uruguay, Yemen.
 - b) The following 15 participating States submitted credentials for the participation at the Conference without full powers for signing the Statute of the International Renewable Energy Agency in full compliance with rule 3 of the rules of procedure of the Conference: Bangladesh, Belarus, Belgium, Brunei Darussalam, Cameroon, Croatia, Cuba, Czech Republic, Hungary, Jamaica, Kuwait, Monaco, Namibia, Oman, Qatar.
 - c) Madagascar was represented by its Minister of Foreign Affairs at the signing ceremony.
 - d) The credentials and full powers of the following 14 participating States were deemed to be sufficient, but still need further confirmation to the Depository by the issuing States within three months upon the date of signature: Afghanistan, Argentina, Burkina Faso, Côte d'Ivoire, France, Guatemala, Honduras, Israel, Montenegro, Nicaragua, Nigeria, Peru, Philippines, Tajikistan.
 - Failure to provide sufficient confirmation would render the respective signatures invalid.
 - e) The credentials and full powers of the following 10 participating States that produced full powers for signing the Statute of IRENA were deemed to be sufficient as full powers for the adoption of the resolution on establishing a Preparatory Commission for the International Renewable Energy Agency: Bulgaria, Ethiopia, Ghana, Latvia, Luxembourg, Netherlands, Poland, Republic of Korea, Slovenia, Zambia.

f) The following 34 States and the European Community attended the Conference as observers, but without providing credentials in full compliance with rule 3 of the rules of procedure of the Conference: Albania, Angola, Australia, Bosnia and Herzegovina, Brazil, China, Costa Rica, Ecuador, El Salvador, Equatorial Guinea, Estonia, India, Indonesia, Iraq, Japan, Kazakhstan, Kenya, Malaysia, Malta, Mexico, Mozambique, New Zealand, Pakistan, Panama, Rwanda, Saudi Arabia, Slovakia, South Africa, Switzerland, Thailand, Turkmenistan, Ukraine, United Kingdom of Great Britain and Northern Ireland, United States of America.

The *Parties* to this Statute,

desiring to promote the widespread and increased adoption and use of renewable energy with a view to sustainable development,

inspired by their firm belief in the vast opportunities offered by renewable energy for addressing and gradually alleviating problems of energy security and volatile energy prices,

convinced of the major role that renewable energy can play in reducing greenhouse gas concentrations in the atmosphere, thereby contributing to the stabilisation of the climate system, and allowing for a sustainable, secure and gentle transit to a low carbon economy,

desiring to foster the positive impact that renewable energy technologies can have on stimulating sustainable economic growth and creating employment,

motivated by the huge potential of renewable energy in providing decentralised access to energy, particularly in developing countries, and access to energy for isolated and remote regions and islands,

concerned about the serious negative implications that the use of fossil fuels and the inefficient use of traditional biomass can have on health,

convinced that renewable energy, combined with enhanced energy efficiency, can increasingly cover the anticipated steep increase in global energy needs in the coming decades,

affirming their desire to establish an international organisation for renewable energy, that facilitates the cooperation between its Members, while also establishing a close collaboration with existing organisations that promote the use of renewable energy,

have agreed as follows:

Article I

Establishment of the Agency

A. The Parties to this Statute hereby establish the International Renewable Energy Agency (hereinafter referred to as "the Agency") in accordance with the following terms and conditions.

B. The Agency is based on the principle of the equality of all its Members and shall pay due respect to the sovereign rights and competencies of its Members in performing its activities.

Article II

Objectives

The Agency shall promote the widespread and increased adoption and the sustainable use of all forms of renewable energy, taking into account:

a.) national and domestic priorities and benefits derived from a combined approach of renewable energy and energy efficiency measures, and

b.) the contribution of renewable energy to environmental preservation, through limiting pressure on natural resources and reducing deforestation, particularly tropical deforestation, desertification and biodiversity loss; to climate protection; to economic growth and social cohesion including poverty alleviation and sustainable development; to access to and security of energy supply; to regional development and to inter-generational responsibility.

Article III

Definition

In this Statute the term "renewable energy" means all forms of energy produced from renewable sources in a sustainable manner, which include, inter alia:

1. bioenergy;

2. geothermal energy;
3. hydropower;
4. ocean energy, including inter alia tidal, wave and ocean thermal energy;
5. solar energy; and
6. wind energy.
Article IV
Activities
A. As a centre of excellence for renewable energy technology and acting as a facilitator and catalyst, providing experience for practical applications and policies, offering support on all matters relating to renewable energy and helping countries to benefit from the efficient development and transfer of knowledge and technology, the Agency performs the following activities:
1. In particular for the benefit of its Members the Agency shall:
a.) analyse, monitor and, without obligations on Members' policies, systematise current renewable energy practices, including policy instruments, incentives,

investment mechanisms, best practices, available technologies, integrated systems and equipment, and success-failure factors;

- b.) initiate discussion and ensure interaction with other governmental and non-governmental organisations and networks in this and other relevant fields;
- c.) provide relevant policy advice and assistance to its Members upon their request, taking into account their respective needs, and stimulate international discussions on renewable energy policy and its framework conditions;
- d.) improve pertinent knowledge and technology transfer and promote the development of local capacity and competence in Member States including necessary interconnections;
- e.) offer capacity building including training and education to its Members;
- f.) provide to its Members upon their request advice on the financing for renewable energy and support the application of related mechanisms;
- g.) stimulate and encourage research, including on socio-economic issues, and foster research networks, joint research, development and deployment of technologies; and

- h.) provide information about the development and deployment of national and international technical standards in relation to renewable energy, based on a sound understanding through active presence in the relevant fora.
- 2. Furthermore, the Agency shall disseminate information and increase public awareness on the benefits and potential offered by renewable energy.
- B. In the performance of its activities, the Agency shall:
 - 1. act in accordance with the purposes and principles of the United Nations to promote peace and international cooperation, and in conformity with policies of the United Nations furthering sustainable development;
 - 2. allocate its resources in such a way as to ensure their efficient utilisation with a view to appropriately address all its objectives and perform its activities for achieving the greatest possible benefit for its Members and in all areas of the world, bearing in mind the special needs of the developing countries, and remote and isolated regions and islands;
 - 3. cooperate closely and strive for establishing mutually beneficial relationships with existing institutions and organisations in order to avoid unnecessary duplication of work and build upon and make efficient and effective use of resources and on-going activities by governments, other organisations and agencies, which aim to promote renewable energy.

- C. The Agency shall:
 - 1. submit an annual report on its activities to its Members;
 - 2. inform Members about its policy advice after it was given; and
 - 3. inform Members about consultation and cooperation with and the work of existing international organisations working in this field.

Article V

Work programme and projects

- A. The Agency shall perform its activities on the basis of the annual work programme, prepared by the Secretariat, considered by the Council and adopted by the Assembly.
- B. The Agency may, in addition to its work programme, after consultation of its Members and, in case of disagreement, after approval by the Assembly, carry out projects initiated and financed by Members subject to the availability of non-financial resources of the Agency.

Article VI

Membership

- A. Membership is open to those States that are members of the United Nations and to regional intergovernmental economic integration organisations willing and able to act in accordance with the objectives and activities laid down in this Statute. To be eligible for membership to the Agency, a regional intergovernmental economic integration organisation must be constituted by sovereign States, at least one of which is a Member of the Agency, and to which its Member States have transferred competence in at least one of the matters within the purview of the Agency.
- B. Such States and regional intergovernmental economic integration organisations shall become:
 - 1. original Members of the Agency by having signed this Statute and having deposited an instrument of ratification;
 - 2. other Members of the Agency by depositing an instrument of accession after their application for membership has been approved. Membership shall be regarded as approved if three months after the application has been sent to Members no disagreement has been expressed. In case of disagreement the application shall be decided on by the Assembly in accordance with Article IX paragraph H number 1.
- C. In the case of any regional intergovernmental economic integration organisation, the organisation and its Member States shall decide on their respective responsibilities for the performance of their obligations under this Statute. The organisation and its Member States

shall not be entitled to exercise rights, including voting rights, under the Statute concurrently. In their instruments of ratification or accession, the organisations referred to above shall declare the extent of their competence with respect to the matters governed by this Statute. These organisations shall also inform the Depositary Government of any relevant modification in the extent of their competence. In the case of voting on matters within their competence, regional intergovernmental economic integration organisations shall vote with the number of votes equal to the total number of votes attributable to their Member States which are also Members of this Agency.

Article VII

Observers

- A. Observer status may be granted by the Assembly to:
 - 1. intergovernmental and non-governmental organisations active in the field of renewable energy;
 - 2. Signatories that have not ratified the Statute; and
 - 3. applicants for membership whose application for membership has been approved in accordance with Article VI paragraph B number 2.
- B. Observers may participate without the right to vote in the public sessions of the Assembly and its subsidiary organs.

Article VIII

Organs

A.	There are hereby established as the principal organs of the Agency:
	1. the Assembly;
	2. the Council; and
	3. the Secretariat.
	The Assembly and the Council, subject to approval by the Assembly, may establish ch subsidiary organs as they find necessary for the exercise of their functions in
acc	cordance with this Statute.
	Article IX
	The Assembly
A.	1. The Assembly is the supreme organ of the Agency.
	2. The Assembly may discuss any matter within the scope of this Statute or relating to the powers and functions of any organ provided for in this Statute.

- 3. On any such matter the Assembly may:
 - a.) take decisions and make recommendations to any such organ; and
 - b.) make recommendations to the Members of the Agency, upon their request.
- 4. Furthermore, the Assembly shall have the authority to propose matters for consideration by the Council and request from the Council and the Secretariat reports on any matter relating to the functioning of the Agency.
- B. The Assembly shall be composed of all Members of the Agency. The Assembly shall meet in regular sessions which shall be held annually unless it decides otherwise.
- C. The Assembly includes one representative of each Member. Representatives may be accompanied by alternates and advisors. The costs of a delegation's participation shall be borne by the respective Member.
- D. Sessions of the Assembly shall take place at the seat of the Agency, unless the Assembly decides otherwise.
- E. At the beginning of each regular session, the Assembly shall elect a President and such other officials as may be required, taking into account equitable geographic representation. They shall hold office until a new President and other officials are elected at the next

regular session. The Assembly shall adopt its rules of procedure in conformity with this Statute.

- F. Subject to Article VI paragraph C, each Member of the Agency shall have one vote in the Assembly. The Assembly shall take decisions on questions of procedure by a simple majority of the Members present and voting. Decisions on matters of substance shall be taken by consensus of the Members present. If no consensus can be reached, consensus shall be considered achieved if no more than 2 Members object, unless the Statute provides otherwise. When the issue arises as to whether the question is one of substance or not, that question shall be treated as a matter of substance unless the Assembly by consensus of the Members present decides otherwise, which, if no consensus can be reached, shall be considered achieved if no more than 2 Members object. A majority of the Members of the Agency shall constitute a quorum for the Assembly.
- G. The Assembly shall, by consensus of the Members present:
 - 1. elect the members of the Council;
 - 2. adopt at its regular sessions the budget and the work programme of the Agency, submitted by the Council, and have the authority to decide on amendments of the budget and the work programme of the Agency;
 - 3. take decisions relating to the supervision of the financial policies of the Agency, the financial rules and other financial matters and elect the auditor;

4. approve amendments to this Statute;
5. decide on the establishment of subsidiary bodies and approve their terms of reference; and
6. decide on permission to vote in accordance with Article XVII paragraph A.
The Assembly shall by consensus of the Members present, which if no consensus can eached shall be considered achieved if no more than 2 Members object:
1. decide, if necessary, on applications for membership;
2. approve the rules of procedure of the Assembly and of the Council, which shall be submitted by the latter;
3. adopt the annual report as well as other reports;
4. approve the conclusion of agreements on any questions, matters or issues within the scope of this Statute; and
5. decide in case of disagreement between its Members on additional projects in accordance with Article V paragraph B.

- I. The Assembly shall designate the seat of the Agency and the Director-General of the Secretariat (hereinafter referred to as "Director-General") by consensus of the Members present, or, if no consensus can be reached, by a majority vote of two thirds of the Members present and voting.
- J. The Assembly shall consider and approve as appropriate at its first session any decisions, draft agreements, provisions and guidelines developed by the Preparatory Commission in accordance with the voting procedures for the respective issue as outlined in Article IX paragraphs F to I.

Article X

The Council

A. The Council shall consist of at least 11 but not more than 21 representatives of the Members of the Agency, elected by the Assembly. The concrete number of representatives between 11 and 21 shall correspond to the rounded up equivalent of one third of the Members of the Agency to be calculated on the basis of the number of Members of the Agency at the beginning of the respective election for members of the Council. The members of the Council shall be elected on a rotating basis as laid down in the rules of procedure of the Assembly, with a view to ensuring effective participation of developing and developed countries and achieving fair and equitable geographical distribution and effectiveness of the Council's work. The members of the Council shall be elected for a term of two years.

- B. The Council shall convene semi-annually and its meetings shall take place at the seat of the Agency, unless the Council decides otherwise.
- C. The Council shall, at the beginning of each meeting for the duration until its next meeting, elect a Chairperson and such other officials from among its members as may be required. It shall have the right to elaborate its rules of procedure. Such rules of procedure have to be submitted to the Assembly for approval.
- D. Each member of the Council shall have one vote. The Council shall take decisions on questions of procedure by a simple majority of its members. Decisions on matters of substance shall be taken by a majority of two thirds of its members. When the issue arises as to whether the question is one of substance or not, that question shall be treated as a matter of substance unless the Council, by a majority of two thirds of its members, decides otherwise.
- E. The Council shall be responsible and accountable to the Assembly. The Council shall carry out the powers and functions entrusted to it under this Statute, as well as those functions delegated to it by the Assembly. In so doing, it shall act in conformity with the decisions and with due regard to the recommendations of the Assembly and assure their proper and continuous implementation.

F. The Council shall:

1. facilitate consultations and cooperation among Members;

- 2. consider and submit to the Assembly the draft work programme and the draft budget of the Agency;
- 3. approve arrangements for the sessions of the Assembly including the preparation of the draft agenda;
- 4. consider and submit to the Assembly the draft annual report concerning the activities of the Agency and other reports as prepared by the Secretariat according to Article XI paragraph E number 3 of this Statute;
- 5. prepare any other reports which the Assembly may request;
- 6. conclude agreements or arrangements with States, international organisations and international agencies on behalf of the Agency, subject to prior approval by the Assembly;
- 7. substantiate the work programme as adopted by the Assembly with a view to its implementation by the Secretariat and within the limits of the adopted budget;
- 8. have the authority to refer to the Assembly matters for its consideration; and
- 9. establish subsidiary organs, when necessary, in accordance with Article VIII paragraph B, and decide on their terms of reference and duration.

Article XI

The Secretariat

- A. The Secretariat shall assist the Assembly, the Council, and their subsidiary organs in the performance of their functions. It shall carry out the other functions entrusted to it under this Statute as well as those functions delegated to it by the Assembly or the Council.
- B. The Secretariat shall comprise a Director-General, who shall be its head and chief administrative officer, and such staff as may be required. The Director-General shall be appointed by the Assembly upon the recommendation of the Council for a term of four years, renewable for one further term, but not thereafter.
- C. The Director-General shall be responsible to the Assembly and the Council, inter alia for the appointment of the staff as well as the organisation and functioning of the Secretariat. The paramount consideration in the employment of the staff and in the determination of the conditions of service shall be the necessity of securing the highest standards of efficiency, competence and integrity. Due regard shall be paid to the importance of recruiting the staff primarily from Member States and on as wide a geographical basis as possible, taking particularly into account the adequate representation of developing countries and with emphasis on gender balance. In preparing the budget the proposed recruitment shall be guided by the principle that the staff shall be kept to a minimum necessary for the proper discharge of the responsibilities of the Secretariat.
- D. The Director-General or a representative designated by him or her shall participate, without the right to vote, in all meetings of the Assembly and of the Council.

E. The Secretariat shall:

- 1. prepare and submit to the Council the draft work programme and the draft budget of the Agency;
- 2. implement the Agency's work programme and its decisions;
- 3. prepare and submit to the Council the draft annual report concerning the activities of the Agency and such other reports as the Assembly or the Council may request;
- 4. provide administrative and technical support to the Assembly, the Council and their subsidiary organs;
- 5. facilitate communication between the Agency and its Members; and
- 6. circulate the policy advice after it was given to the Members of the Agency in accordance with Article IV paragraph C number 2 and prepare and submit to the Assembly and the Council a report on its policy advice for each of their sessions. The report to the Council shall include also the planned policy advice in implementing the annual work programme.
- F. In the performance of their duties, the Director-General and the other members of the staff shall not seek or receive instructions from any government or from any other source external to the Agency. They shall refrain from any action that might reflect on their positions as international officers responsible only to the Assembly and the Council. Each

Member shall respect the exclusively international character of the responsibilities of the Director-General and the other members of the staff and shall not seek to influence them in the discharge of their responsibilities.

Article XII

The budget

- A. The budget of the Agency shall be financed by:
 - 1. mandatory contributions of its Members, which are based on the scale of assessments of the United Nations, as determined by the Assembly;
 - 2. voluntary contributions; and
 - 3. other possible sources

in accordance with the financial rules to be adopted by the Assembly by consensus, as laid down in Article IX paragraph G of this Statute. The financial rules and the budget shall secure a solid financial basis of the Agency and shall ensure the effective and efficient implementation of the Agency's activities, as defined by the work programme. Mandatory contributions will finance core activities and administrative costs.

B. The draft budget of the Agency shall be prepared by the Secretariat and submitted to the Council for examination. The Council shall either forward it to the Assembly with a recommendation for approval or return it to the Secretariat for review and re-submission.

C. The Assembly shall appoint an external auditor who shall hold office for a period of four years and who shall be eligible for re-election. The first auditor shall hold office for a period of two years. The auditor shall examine the accounts of the Agency and shall make such observations and recommendations as deemed necessary with respect to the efficiency of the management and the internal financial controls.

Article XIII

Legal personality, privileges and immunities

A. The Agency shall have international legal personality. In the territory of each Member and subject to its national legislation, it shall enjoy such domestic legal capacity as may be necessary for the exercise of its functions and the fulfilment of its purposes.

B. Members shall decide upon a separate agreement on privileges and immunities.

Article XIV

Relations with other organisations

Subject to the approval of the Assembly the Council shall be authorised to conclude agreements on behalf of the Agency establishing appropriate relations with the United Nations and any other organisations whose work is related to that of the Agency. The provisions of this Statute shall not affect the rights and obligations of any Member deriving from any existing international treaty.

Article XV

Amendments and withdrawal, review

- A. Amendments to this Statute may be proposed by any Member. Certified copies of the text of any amendment proposed shall be prepared by the Director-General and communicated by him to all Members at least ninety days in advance of its consideration by the Assembly.
- B. Amendments shall come into force for all Members:
 - 1. when approved by the Assembly after consideration of observations submitted by the Council on each proposed amendment; and
 - 2. after all the Members have consented to be bound by the amendment in accordance with their respective constitutional processes. Members shall express their consent to be bound by depositing a corresponding instrument with the Depositary referred to in Article XX paragraph A.
- C. At any time after five years from the date when this Statute takes effect in accordance with paragraph D of Article XIX, a Member may withdraw from the Agency by notice in writing to that effect given to the Depositary referred to in Article XX paragraph A, which shall promptly inform the Council and all Members.
- D. Such withdrawal shall take effect at the end of the year in which it is expressed. Withdrawal by a Member from the Agency shall not affect its contractual obligations

entered into pursuant to Article V paragraph B or its financial obligations for the year in which it withdraws.

Article XVI

Settlement of disputes

A. Members shall settle any dispute between them concerning the interpretation or application of this Statute by peaceful means in accordance with Article 2 paragraph 3 of the Charter of the United Nations and, to this end, shall seek a solution by the means indicated in Article 33 paragraph 1 of the Charter of the United Nations.

B. The Council may contribute to the settlement of a dispute by whatever means it deems appropriate, including offering its good offices, calling upon the Members to a dispute to start the settlement process of their choice and recommending a time limit for any agreed procedure.

Article XVII

Temporary suspension of rights

A. Any Member of the Agency which is in arrears with its financial contributions to the Agency shall have no right to vote if its arrears reach or exceed the amount of its contributions for the two preceding years. However, the Assembly may permit this

Member to vote if it is convinced that the non-payment is due to circumstances beyond the Member's control.

B. A Member which has persistently violated the provisions of this Statute or of any agreement entered into by it pursuant to this Statute may be suspended from the exercise of the privileges and rights of membership by the Assembly acting by a two-thirds majority of the Members present and voting upon recommendation of the Council.

Article XVIII

Seat of the Agency

The seat of the Agency shall be determined by the Assembly at its first session.

Article XIX

Signature, ratification, entry into force and accession

A. This Statute shall be open for signature at the Founding Conference by all States that are members of the United Nations and regional intergovernmental economic integration organisations as defined in Article VI paragraph A. It shall remain open for signature until the date this Statute enters into force.

- B. For States and regional intergovernmental economic integration organisations as defined in Article VI paragraph A having not signed this Statute, this Statute shall be open for accession after their membership has been approved by the Assembly in accordance with Article VI paragraph B number 2.
- C. Consent to be bound by this Statute shall be expressed by depositing an instrument of ratification or accession with the Depositary. Ratification of or accession to this Statute shall be effected by States in accordance with their respective constitutional processes.
- D. This Statute shall enter into force on the thirtieth day after the date of deposit of the twenty-fifth instrument of ratification.
- E. For States or regional intergovernmental economic integration organisations having deposited an instrument of ratification or accession after the entry into force of the Statute, this Statute shall enter into force on the thirtieth day after the date of deposit of the relevant instrument.
- F. No reservations may be made to any of the provisions contained in this Statute.

Article XX

Depositary, registration, authentic text

A. The Government of the Federal Republic of Germany is hereby designated as the Depositary of this Statute and any instrument of ratification or accession.

- B. This Statute shall be registered by the Depositary Government pursuant to Article 102 of the Charter of the United Nations.
- C. This Statute, done in English, shall be deposited in the archives of the Depositary Government.
- D. Duly certified copies of this Statute shall be transmitted by the Depositary Government to the governments of States and to the executive organs of regional intergovernmental economic integration organisations which have signed or have been approved for membership according to Article VI paragraph B number 2.
- E. The Depositary Government shall promptly inform all Signatories to this Statute of the date of each deposit of any instrument of ratification and the date of entry into force of the Statute.
- F. The Depositary Government shall promptly inform all Signatories and Members of the dates on which States or regional intergovernmental economic integration organisations subsequently become Members thereto.
- G. The Depositary Government shall promptly send new applications for membership to all Members of the Agency for consideration in accordance with Article VI paragraph B number 2.

Resolution

(IRENA)

The Conference on the establishment of the International Renewable Energy Agency,

having signed the Statute of the International Renewable Energy Agency,

having decided to take all possible measures to ensure the rapid and effective establishment of the International Renewable Energy Agency,

having decided to this end to establish a Preparatory Commission,

decides as follows:

- 1. There is hereby established the Preparatory Commission for the International Renewable Energy Agency (hereinafter referred to as "the Commission") for the purposes of:
 - a.) carrying out the necessary preparation for the first meeting of the Assembly and for the effective and early coming into force and implementation of the Statute of the International Renewable Energy Agency (hereinafter referred to as "the Statute"), particularly by establishing the interim working structures that are necessary for this purpose;
 - b.) taking the necessary preliminary steps in order to ensure the early presence, profile and influence of the Agency in the international renewables field; and
 - c.) carrying out the necessary activities in order to ensure the effective preliminary implementation of the objectives of the Statute as soon as possible.

- 2. The Commission shall come into existence on the first day the Statute is open for signature.
- 3. The Commission shall be composed of one representative of each of the Signatories of the Statute.
- 4. The expenses of the Commission shall be met by voluntary contributions in cash or in kind, and for this purpose the Commission shall make the necessary arrangements.
- 5. The Commission shall have international legal personality. Subject to national legislation, it may enjoy such domestic legal capacity as may be necessary for the exercise of its functions and the fulfilment of its purposes.
- 6. The Commission shall meet on the day it is established and as often as it deems necessary thereafter, subject to its financial resources.
- 7. The Commission shall take decisions in accordance with the majority requirements for the respective issue foreseen in Article IX of the Statute relating to the Assembly of the Agency.
- 8. Concerning its organisation and capacity to work the Commission shall, inter alia:
 - a.) elect its Chairman and other officers, and establish such committees as it deems necessary;
 - b.) in order to offer the Agency effective working structures for adoption by the Assembly:
 - (1) approve at its first session a selection procedure for the interim seat and the Interim Director-General;

- (2) appoint an Interim Director-General, who shall serve until the appointment of the Agency's Director-General in accordance with Article IX paragraph I of the Statute;
- (3) decide on the interim seat, which shall serve as the headquarters until the Assembly decides on the final seat of the Agency in accordance with Article IX paragraph I; and
- (4) establish an Interim Secretariat to assist the Commission, to exercise such functions and powers as the Commission may determine and to appoint the necessary staff in accordance with Article XI paragraph C of the Statute;
- c.) develop and adopt such interim rules of procedure, interim financial, staff and other administrative regulations and such an interim working programme as may be necessary for the effective implementation of its purposes.
- 9. The Commission shall designate the interim seat of the Secretariat and the Interim Director-General of the Secretariat by consensus of the Signatories present, or, if no consensus can be reached, by a majority vote of two-thirds of the Signatories present and voting.
- 10. The Commission shall prepare, inter alia, the following documents concerning the organisation and work of the Agency and requiring immediate attention after the entry into force of the Statute:
 - a.) a provisional agenda for the first meeting of the Assembly;
 - b.) draft rules of procedure of the Assembly and the Council;

- c.) a draft budget and financial rules of the Agency;
- d.) a draft work programme, including recommendations on relationships with other relevant international and regional organisations;
- e.) draft documents concerning the permanent recruitment of staff;
- f.) a draft procedure for the election of members of the Council in accordance with Article X paragraph A of the Statute, according to which the Commission shall make proposals for the elections of members for the first Council;
- g.) a comprehensive report of its activities and all matters within its mandate to be submitted to the Assembly for its first meeting; and
- h.) such reports, studies and recommendations as it deems relevant in order to ensure the effective and early start of the Agency's activities.
- 11. The Commission may, for the further implementation of its purposes, carry out such activities of the Agency, as set out in the Statute, as may be necessary for the preliminary implementation of the Agency's objectives.
- 12. The Commission shall remain in existence until the Statute comes into force and thereafter until the conclusion of the first session of the Assembly and the election of the Council in accordance with the Statute.
